TCM offers discretionary investment management and investment advisory services for domestic equity and global equity strategies, utilizing securities that include, but are not limited to, common stock, preferred stock, options contracts, corporate bonds, municipal bonds and U.S. government bonds.

TCM offers investment advice to individuals, pension and profit sharing plans, trusts, estates, charitable organizations, academic endowments, corporations, a registered investment company and other business entities through separately managed accounts. TCM provides investment management services as an adviser to the Tran Capital Focused Fund, a registered investment company.

We will manage your assets on a discretionary basis and in accordance to the advisory agreement.

Item 3. Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?

TCM charges a tiered, percentage-based fee, calculated on the market value of the assets in the client's account. Fees are paid in multiple ways; fees are payable quarterly in arrears and some are paid in advance. Alternative frequency of payment and/or methods of calculation may be available, where appropriate or upon a client's request. The quarterly fee is calculated by multiplying the fair market value of cash and securities in the portfolio as of the close of the quarter by the applicable quarterly percentage.

TCM's management fees are ordinarily calculated by TCM and are calculated on TCM's valuation of the assets in the client's portfolio. In certain instances, TCM and the client may agree that the fees should be calculated based upon the custodian's valuation of the assets in the client's portfolio. In addition, when TCM manages multiple accounts for a particular client, or for a related group of clients, fee calculations may be based on the total assets under management or a relationship fee discount may be available.

Brokerage commissions, transaction fees, and other related costs and expenses are exclusive of and in addition to the advisory fee. We do not receive any portion of these commissions, fees, and costs. Other fees and costs you will pay will be outlined in the applicable advisory agreement.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.
